Executive Summary

Attached are session proceedings from the 1st Prosperity Roundtable held on March 6, 2007. The purpose of this session was: to identify main growth drivers and real opportunities, in a way that engages the business community, in order to increase jobs in and prosperity across Peterborough and the County.

The group discussed and short listed the most important drivers of growth. Based on this, over 70 opportunities were identified to increase prosperity in the region. These were prioritized based on doability and impact. Fifteen ideas were selected and these were further prioritized. The steering committee agreed to refine these and the group committed to meet again in mid April to further refine the priorities. Below are the key points from the morning.

The **Main Drivers of Growth** in Peterborough and the County are:

1. *Health care and education facilities*: continued need for cooperative effort between education and the PRHC to attract & retain strong medical community;
2. *Commitment to invest in economic development* by regional partners, City, County;
3. *Development of infrastructure* to facilitate growth (e.g. roads, internet, sewers, waste);
4. Availability of affordable, *serviced high value land*;
5. *Arts, cultural & recreational base*;
6. *Unified political leadership*: co-operation & support of all community leaders & politicians;
7. *High quality of life* and quality business environment;
8. *Locational Advantages*: proximity to major markets

The **Top Ten Opportunities** to increase prosperity are:

1. (Long Term) *Enhance infrastructure* & promote managed growth;
2. (Short) *Development of vision, mission & guiding principles* for dec-making. This includes: establishing terms of reference to identify functionality and expansion of joint services city/county;
3. (Short) *Industrial land development*: airport, industrial park, Trent lands, serviced industrial property;
4. (Short) Integrated *regional transportation strategy* which includes rail, airport, Parkway, completion of 407 extension;
5. (Short) Partnership to *fast track planning & development* & reduce Red Tape (e.g. for new investors/companies looking at our area);
6. (Long Term) Structure *local taxation* in a manner which facilitates growth. This includes: reduction of commercial property taxes in the Region;
7. (Short) Actively revitalize & *invest in downtown*: including a convention center;
8. (Short) Develop *Tourism strategy*. e.g. create Tourism "Packages" and market them;
9. (Short) Explore best practices around *family physician recruitment*;
10. (Short) Integrated *marketing and branding* committee for the community. This includes: rename/identify Peterborough region with consistent marketing signage
